 - o 5 Items to put to a membership vote
 - ➤ 1. Add a student membership level that is non-voting and does not receive a RA card (see #5).
 - 2. Individual members get to vote.
 - ➤ 3. Since Organizational members represent many to the Individual members who represent one, Organizational member votes are weighted 3 to 1 against Individual member votes (each member gets one vote, but an Organizational member vote is equivalent to 3 votes).
 - ➤ 4. Offer a one-year pilot membership incentive. Members who bring in a new member will receive a free lunch at the next meeting. A referral box field will be

- included on the membership form for new members to indicate referring member. After one year, assess the success and costs of the incentive and present results to membership for continuation or discontinuation.

Increase membership dues to increase annual revenue approximately \$1,000 to ensure the long-term financial health of CMA and account for new recurring payments (Zoom, QuickBooks), increases in general costs (special event food, website), and assist in the transition to full online payment services (for lunch and membership):

- Museum updates!
 - South wall has been extended by 60ft on both levels.
- Video Presentation:
 - O The museum received funding of \$10 million dollars to expand the exhibits and displays to improve visitor experience. This included:
 - Updating galleries
 - Rotating exhibitions
 - Adding 2 classrooms
 - Creating a multi-purpose space
 - Updating the facility to be ADA Compliant, which increases the museum's sustainability.
 - Developing and managing the museum's collection management software
 - O Site Preparation:
 - Replacing the AC and Heating towers with two new towers. This will ensure that if one tower fails the other will pick up the slack so repairs can be made.
